



## *SSB 5030 (School Counseling Programs)*

### 1. **Purpose:**

The one-time \$27,000 in funding provided through this proviso was intended to support the implementation of Substitute Senate Bill 5030. SSB5030 is mandating the transition across Washington to the implementation of comprehensive school counseling programs (CSCP) based on the national best practice standards of the American School Counseling Association (ASCA).

### 2. **Description of services provided:**

We used this funding to purchase and distribute to all 295 school districts a copy of the ASCA National Model, A Framework for School Counseling Programs, 4th Edition and the ASCA National Model Implementation Guide: Manage and Assess, 2nd Edition.

### 3. **Criteria for receiving services and/or grants:**

No criteria was applied. All districts' superintendents received both books.
