COMES NOW the Office of Superintendent of Public Instruction (OSPI), under the authority granted by the laws of the state of Washington, having reviewed the file of the above-referenced case, and having considered the entire evidence contained therein, does hereby permanently revoke the Washington Education Certificate, No. 405077R, of Jesus Barcnas, based on the Findings of Fact and Conclusions of Law set forth below:

### FINDINGS OF FACT

1. Jesus Barcnas was issued a Washington Education Certificate, No. 405077R, on January 21, 2003. That certificate expired on June 30, 2008. The actions described in the following Findings of Fact occurred while Washington Education Certificate, No. 405077R, was valid.

2. Jesus Barcnas was employed by the Wapato School District.

3. On December 26, 2007, the Office of Professional Practices, within OSPI, did receive information, through news media, that Jesus Barcenas had been charged in Yakima County Superior Court with two counts of Child Rape, First Degree, and three counts of Child Rape, Second Degree.

4. Jesus Barcenas was employed at Wapato School District from July 31, 2003 to June 13, 2007.

5. From September 2006 through December 2007, Jesus Barcenas had sexual intercourse and sexual contact with C.J.C., a minor female student in the Wapato School District; Yakima Police Department report #07-21785.

6. On December 20, 2007, an Information and Declaration of Probable Cause were filed in Yakima County Superior Court, Cause Number 07-1-02816-7, charging Jesus Barcenas with: two counts of First Degree Rape of a Child, RCW 9A.44.073; two counts of First Degree Child Molestation, RCW 9A.44.083; three counts of Second Degree Rape of a Child, RCW 9A.44.076; and three counts of Second Degree Child Molestation, RCW 9A.44.086.

7. On December 21, 2007, Jesus Barcenas was arrested by detectives from the Yakima Police Department and booked and incarcerated into the Yakima County Jail for Rape of a Child 1<sup>st</sup> Degree and 2<sup>nd</sup> Degree; Yakima Police Department report #07-21785.

8. On January 8, 2009, an Amended Information and Declaration of Probable Cause were filed in Yakima County Superior Court, Cause Number 07-1-02816-7, charging Jesus Barcenas with: two counts of First Degree Rape of a Child, RCW 9A.44.073; two counts of First Degree Child Molestation, RCW 9A.44.083; three counts of Second Degree Rape of a Child, RCW 9A.44.076; and three counts of Second Degree Child Molestation, RCW 9A.44.086.

9. On November 5, 2009, Jesus Barcenas, after a jury trial, was found guilty of two counts of Second Degree Rape of a Child (felony), RCW 9A.44.076; Yakima County Superior Court, Cause Number 07-1-02816-7.

10. Jesus Barcenas has been convicted of a crime identified in Revised Code of Washington (RCW) 28A.410.090(3). Such a conviction authorizes OSPI to permanently revoke the Education Certificate.

11. Good moral character and personal fitness is a continuing requirement to maintain a Washington Education Certificate.

CONCLUSIONS OF LAW


1. OSPI has jurisdiction over Jesus Barcenas and over the subject matter of this action.
  
2. OSPI has shown by clear and convincing evidence that the Washington Education Certificate, No. 405077R, of Jesus Barcenas, should be revoked, as provided for in WAC 181-86-075.
  
3. Jesus Barcenas has violated RCW 28A.410.090, WAC 181-87-080, WAC 181-87-060, WAC 181-86-013, and/or WAC 181-86-014.

ORDER

THEREFORE, it is hereby ordered that the Washington Education Certificate, No. 405077R, of Jesus Barcenas, be permanently revoked.
