Expand Post-Secondary (GKHS)

1. **Purpose:**

The proviso is used to expand and support Pierce College in offering college-level courses at Graham-Kapowsin High School in the Bethel School District in order to increase access to college courses in the southeast Pierce County area. Currently, limited public transportation and traffic concerns present significant restrictions to college access. By offering college courses at GK, current high school students are more readily able to access the Running Start program. The courses also increase the opportunity for recent graduates to attend college. And, the courses are open to other community members.

2. Description of services provided:

One hundred percent (100%) of the funds passed through to Pierce College. The funds will be used to pay for the expansion of the college courses offered at Graham-Kapowsin High School through staffing and marketing materials.

7. **Programmatic changes since inception (if any):**

Work continued during the COVID-19 delivery of instruction and will continue, with 2020 supplemental funding, during the 2020–21 school year. Pierce College at Graham-Kapowsin is continually increasing in enrollment.

8. **Evaluations of program/major findings:**

- Pierce College at Graham is now an established site with college programing and processes closely integrated with district-wide systems.
- Northwest Community College and Universities accrediting body (NWCCU) certified the Pierce College at Graham site.
- The annual courses schedule, developed collaboratively with Instructional Deans and Division Chairs, ensures the availability of a "Graham Pathway," with courses for full-time college-ready students to complete an AA Direct Transfer Agreement in six quarters.
- Pierce College at Graham courses were offered at Graham-Kapowsin High School fall, winter, and spring quarters on a late afternoon and evening schedule and in multiple modalities to serve place-bound students and working adults.
- The Pierce College at Graham brand, "Your Neighborhood College," is widely advertised through BSD and Pierce College District channels, including signage at BSD sites, digital media distribution to BSD families, neighboring school districts, as well as the greater community.
- "Bethel Schools Project Manager," a permanent, full-time position, was funded August 2019 to ensure effective program/site coordination, continuous improvements, and program growth.
- "Bethel Schools Project" joint team meets quarterly to review progress toward goals and to explore additional strategies for increasing/enhancing higher education opportunities for South Pierce County residents.

11. Statutory and/or budget language:

ESSB 6168 Sec. 520 (21) - \$125,000 of the general fund—state appropriation for fiscal year 2020 and \$125,000 of the general fund—state appropriation for fiscal year 2021 are provided solely for Bethel School District to expand post-secondary education opportunities at Graham-Kapowsin High School.
