Immigrants in the Workplace

1. Purpose:

Funding was provided to OSPI for Attorney General costs related to implementation of E2SSB 5497 (2019 Session). The bill requires the Attorney General to develop model policies limiting immigration enforcement in public schools, health facilities operated by the state or its political subdivisions, courthouses, and shelters to ensure safe access to Washington residents regardless of immigration or citizenship plan. State agencies must review must and update their policies and information systems to limit the personal information agencies requests and retains to only the information necessary to perform agency duties.

2. Description of services provided:

As stated in its fiscal note on the bill, OSPI updates policies on an as-needed basis within existing resources. The fiscal note indicated funding would be needed to cover additional Attorney General charges for review of policies. The projected amount of funding needed was based on the Attorney General's fiscal note.

3. Criteria for receiving services and/or grants:

No grants were awarded. OSPI assumes its on-going update of policies benefits the entire K-12 educational system.
