





Review 1

Rev ID 13

One concern could be that the curriculum was created by ETR (Education, Training, and Research) and Planned Parenthood. I think from a teaching standpoint making it known from the beginning that the information being used would be in part created by Planned Parenthood would be important to disclose.

I think the materials are well done and I really didn't get a slant from Planned Parenthood with regards to them trying to push any agenda. I would definitely consider using this curriculum.

Review 2

I thought this was a GREAT curriculum and one that I would use in my high school classes. In fact, there were several sections that I will be "stealing" from to update some of what I am doing.

The beginning of the resource includes a section that has "Impact Evaluation Results." I was impressed with this and found it interesting to see the affects the curriculum has had on teen sexual behaviors.

I was also appreciative that there is a section on "Male responsibility for pregnancy prevention." I think this is an important angle considering the overwhelming burden for contraception on the side of females.

The list of National Standards at the beginning of each unit is a great support.

The diagrams for reproductive organs are well done and the matching exercises for students are also helpful.

I also love the "Talking points" for teachers that are available throughout.

This curriculum gets my stamp of approval!

Review 3

Rev ID 20

Requires "Get Real" teacher training by Planned Parenthood League of Mass. or ETR, or a certified "Get Real" replication partner.

No pictures of youth beyond the front cover. This helps keep materials looking current as photos date the curriculum, but also does not reflect very diverse populations, as those represented appear white.

Slightly confusing layout of student workbook.

Would to see explicit teacher information on how to answer values questions (protocol).
