COMES NOW the Office of Superintendent of Public Instruction (OSPI), under the authority granted by the laws of the state of Washington, having reviewed the file of the above-referenced case, and having considered the entire evidence contained therein, does hereby revoke the Washington Education Certificate, No. 473479D, of Gregory Huber-Mayotte, based on the Findings of Fact and Conclusions of Law set forth below:

FINDINGS OF FACT

1. Gregory Huber-Mayotte was issued a Washington Education Certificate, No. 473479D, on July 26, 2010. That certificate currently remains valid.

2. Gregory Huber-Mayotte was employed by the Evergreen Public Schools.

3. On January 30, 2012, the Office of Professional Practices, within OSPI, did receive a complaint letter from the superintendent of the Evergreen Public Schools alleging a lack of personal fitness, or a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) 181-87, by Gregory Huber-Mayotte.

4. Between and including 2005 to and including July 2008, Gregory Huber-Mayotte intentionally, knowingly and unlawfully took and used money and property belonging to his mother, Dorothy Huber, and used said money and property in an unlawful manner. During this time frame, Gregory Huber-Mayotte unlawfully, intentionally and knowingly took and used over \$182,000 of Dorothy Huber's money and property.

5. On July 21, 2008. Laura Aust, LJA Fiduciary Services, was appointed as guardian/conservator of Dorothy Huber.

6. In September 2008, Dorothy Huber's house, located at 2925 SE Cleveland Dr, Gresham, ORE, was foreclosed upon due in part to actions by Gregory Huber-Mayotte.

7. On March 9, 2009 and April 29, 2009, Gregory Huber-Mayotte participated in a deposition as part of the conservatorship/guardianship court case involving his mother, Dorothy Huber; Multnomah County Court Cause #080590736.

8. On March 12, 2009, Portland Police Bureau initiated a criminal investigation into Gregory Huber-Mayotte's actions with Dorothy Huber's money and property; Portland Police Bureau report #09-22779.

9. On an unknown date between March 12, 2009 and July 29, 2010, Gregory Huber-Mayotte was interviewed by Portland Police Bureau detective/s regarding the unlawful use of Dorothy Huber's money and property.

10. On September 2, 2009, Gregory Huber-Mayotte was issued an education certificate by the State of Oregon Teacher Standards and Practices Commission (TSPC).

11. On September 12, 2009, Gregory Huber-Mayotte signs and submits an Application for Washington State Teacher Certification and accompanying Character and Fitness Supplement. Gregory Huber-Mayotte signed the Affidavit for the Character and Fitness Supplement, which states in part "If the information provided or answer(s) to any question on the application or character and fitness supplement changes prior to my being granted certification, I must immediately notify the Office of Professional Practices and my college/university of I am a college/university student."

12. On July 26, 2010, Gregory Huber-Mayotte was issued Washington Education Certificate #473479D. Gregory Huber-Mayotte failed to notify the Office of Professional Practices that he was under investigation by the Portland Police Bureau for theft and criminal mistreatment felony offenses.

13. On July 29, 2010, Portland Police Bureau submitted report #09-22779 to the District Attorney's Office for consideration of charges.

14. On August 10, 2010, Gregory Huber-Mayotte was indicted in Multnomah County by a grand jury on charges of Aggravated Theft in the 1st Degree and two counts of Criminal Mistreatment in the 1st Degree; Multnomah County Circuit Court No. 10-08-33123.

15. On August 26, 2010, Gregory Huber-Mayotte was arrested by Portland Police Bureau on an outstanding felony arrest warrant for the charges of Aggravated Theft in the 1st Degree and two counts of Criminal Mistreatment in the 1st Degree; Portland Police Bureau case #10-070670.

16. On September 2, 2010, Gregory Huber-Mayotte was charged in Clackamas County Circuit Court on a charge of Initiating a False Report; Clackamas County District Court Case #CR1012851..

17. On February 16, 2011, Gregory Huber-Mayotte was convicted of Criminal Mistreatment in the 1st Degree by a plea of no contest in Multnomah County Circuit Court; Multnomah County Circuit Court No. 10-08-33123.

18. On June 7, 2011, Gregory Huber-Mayotte pleaded guilty to the charge of Initiating a False Report in Clackamas County District Court; Clackamas County District Court Case #CR1012851.

19. On January 6, 2012, TSPC revoked Gregory Huber-Mayotte's Oregon education certificate and revoked his right to apply.

20. On January 26, 2012, the Evergreen Public Schools notified Gregory Huber-Mayotte that he was no longer to be considered for use as a substitute teacher.

21. On May 10, 2012, TSPC adopted a Default Order of Revocation of Right to Apply for Gregory Huber-Mayotte.

22. On June 18, 2012, OPP notified Gregory Huber-Mayotte of his opportunity to respond to allegations of misconduct and/or lack of good moral character and personal fitness, as per RCW 28A.410.090. Gregory Huber-Mayotte has not responded to OPP as of July 19, 2012.

23. Good moral character and personal fitness is a continuing requirement to maintain a Washington Education Certificate.

CONCLUSIONS OF LAW

1. OSPI has jurisdiction over Gregory Huber-Mayotte and over the subject matter of this action.

2. OSPI has shown by clear and convincing evidence that the Washington Education Certificate No. 473479D of Gregory Huber-Mayotte, should be revoked for unprofessional conduct and/or lack of good moral character or personal fitness. RCW 28A.410.090, WAC 181-87-050, WAC 181-86-075, WAC 181-86-013, WAC 181-86-014.

ORDER

THEREFORE, it is hereby ordered that the Washington Education Certificate, No. 473479D, of Gregory Huber-Mayotte be revoked.
