# Alternative Learning Experience (ALE) Accelerating Unfinished Learning Grant Application Questions

# **Application and Selection Information**

## **Getting Started**

Many students have unfinished learning and exacerbated social emotional needs due to the COVID pandemic. Universal screening can identify a student's unique academic or social emotional needs, and ALE can address those needs through individualization and acceleration. However, many districts face a variety of barriers to providing individualized scheduling and learning plans due to scheduling constraints and funding formula disparities, thus forcing students to retake entire courses or transfer out of district.

This grant initially opened during winter 2022 to provide funding to supplement ALE apportionment based on identified costs necessary to implement this model and achieve desired outcomes. This grant encourages accelerated learning recovery through academic and social emotional screening, individualizing a response via ALE, and providing the funding for school districts who would otherwise be financially disincentivized to offer ALE. This will reduce the impact of retaking entire courses, create an opportunity to keep students enrolled at their neighborhood schools, and get students back on track with their peers in an accelerated timeline.

This grant will reopen in December 2022 for applications with a narrower scope. The goals of the grant remain the same, screening and addressing the individualized and identified learning gaps of students resulting from the effects of the pandemic. However, the proposals that OSPI will review in this round of applications must specifically support activities outside and beyond the scheduled school day or calendar. These may include but are not limited to extending the day, school week, or school year.

Deadline for this round of applications is 5:00 PM Friday, February 3, 2023. Funds for approved grants must be spent by August 31, 2023.

Participant expectations:

- Identify students' unfinished learning through academic and social/emotional screening.
- Develop individualized learning plans that address identified gaps and accelerate learning recovery during extended day, week, or school year models using ALE.



• Demonstrate if and how the program and supplemental funding impacted student outcomes.

#### Eligibility:

This grant is available to public school districts, charter schools, and tribal compact schools in Washington State. Grantees will be identified by a review process based on successful completion of this application, which requires:

- Basic information about your project including participants, location, target population, etc.
- Short essay responses describing your project and its equity alignments.
- Budget, and list of evidence you will collect.

## **Selection Process**

The goal of this grant program is to provide funding to supplement ALE apportionment for the purpose of accelerating learning recovery using ALE. OSPI is looking for proposals with unique ways of utilizing ALE, those that demonstrate a collaboration between school settings to impact more students, and those that prioritize the needs of underserved student populations.

Each application will be reviewed in three categories: Equity Considerations, Project Design, and Budget and Impact. A complete description of the scoring criteria is available in the Application Scoring Rubric.

The total available grant funding is \$500,000. There is no minimum or maximum budget for individual applicants, but proposals will be closely reviewed in context of the learning that may be achieved and the impact for students.

Applications are due by 5:00 PM on Friday, February 3, 2023.

If your application is approved, next steps may include:

- District commitment to the project.
- Up-to-date local district ALE board policy authorizing ALE.
- District grant program lead will need to complete an iGrants form package.
