CONTINUING EDUCATION CREDIT HOURS (CLOCK HOURS) TEACHER PERFORMANCE ASSESSMENT (TPA) SCORER

Use this form to verify continuing education credit hours (clock hours) for serving as a scorer for the Washington teacher performance assessment (TPA) or for receiving initial training as a scorer. Individual shall receive the equivalent of ten continuing education credit hours (clock hours), up to a total of twenty continuing education credit hours (clock hours) per calendar year for each four TPA assessments scored. Individuals who receive initial training as a scorer for the Washington teacher performance assessment shall receive the equivalent of ten continuing education hours.

WAC 181-85-033(7)

Notwithstanding any provision of this chapter to the contrary, individuals who serve as scorers for the Washington teacher performance assessment shall receive the equivalent of ten continuing education credit hours for each four assessments scored, provided that an individual may not receive more than the equivalent of twenty continuing education credit hours during a calendar year period. Additionally, individuals who receive initial training as scorers for the Washington teacher performance assessment shall receive the equivalent of ten continuing education credit hours.
