

U.S. Foreign Policy

How the United States government interacts with the world affects people across the globe. You will evaluate a specific U.S. foreign policy based on your analysis of its effectiveness.

Your Task

In a cohesive paper or presentation, you will:

- State a claim regarding the effectiveness of a specific U.S. foreign policy and provide evidence in support of your claim.
- Provide reason(s) for your claim, including an analysis of why the policy was implemented for national and/or international interests and considering two or more social science perspectives.*
- Provide evidence for your claim that supports your analysis of the effects of the policy, with discussion of:
 - How the policy affected stakeholders in the United States.
 - How the policy provided benefits for other nations.
 - How the policy imposed costs on other nations.
- Refer explicitly in the paper or presentation to three or more credible sources that provide relevant information:
 - Cite your sources when you draw information from them: for instance, when you summarize, paraphrase, or quote, and when you refer to facts, figures, and ideas.
 - Provide complete publication information for each source in your bibliography or list of works cited.

*Social science perspectives are the lens of the social studies disciplines. Examples include geographic, economic, political, and cultural perspectives.
