

Annual Determinations on LEA Implementation of IDEA 2004 November 2023

As part of ongoing efforts to improve educational outcomes for students with disabilities, OSPI issues annual determinations to every local education agency (LEA) in Washington regarding the LEA's compliance with the *Individuals with Disabilities Education Act* (IDEA 2004). On November 1, 2023, the Office of Superintendent of Public Instruction (OSPI) Special Education division notified LEAs in writing of their preliminary determination level for 2022-23. Determination levels were considered final after the request for reconsideration period ended on November 30, 2023.

The determination notifications issued on November 1, 2023, summarized LEA performance on implementation of Part B of the *IDEA* for the time period beginning July 1, 2022, and ending on June 30, 2023 (school year 2022–23). OSPI is making this information available to the public pursuant to WAC 392-172A-07025. *IDEA* details four categories for LEA determinations. The levels of determination may be:

1. Meets the requirements of *IDEA*;
2. Needs assistance in implementing the requirements of *IDEA*;
3. Needs intervention in implementing the requirements of *IDEA*; or
4. Needs substantial intervention in implementing the requirements of *IDEA*.

IDEA identifies specific technical assistance and/or enforcement actions that the State must take under specific circumstances for LEAs that are not determined to "meet requirements".
