



Career and Technical Education (CTE) 2024-2028 Program Approval Schedule

The purpose of the CTE Course and Program Approval processes is to make certain that all CTE courses:

- Ensure academic rigor;
- Align with the state's education reform requirements and CTE Program Standards;
- Help address the skills gap of Washington's economy; and
- Maintain strong relationships with local CTE advisory councils for the design and delivery of career and technical education.

Beginning in the 2017–18 school year, and annually thereafter, all approved CTE courses will be approved as part of the Program Approval process managed in the Education Data System (EDS). Program Approval review and submission windows have enforced due dates, and programs are approved on an annual cycle.

IMPORTANT: Failure to complete Program Approval annually results in the need to submit new applications for each course offered in the program area under review before they can be offered as approved CTE courses. Courses that do not have current state-level approval may not be claimed for CTE enhanced funding or used to meet the requirements of the CTE Graduation Pathway.
