If you have not met the deadline you will not be eligible to receive funds from the 2024–25 Perkins application



  the Workforce Training & Education Coordinating Board
  (WTECB)
- Take the survey to give feedback before the public engagement: <u>Workforce Development Survey</u>
  - The survey is about the workforce system at large, not just Perkins







Topic of Interest – Writing for Perkins Reserve

#### General Grant Details

- Read the entire grant application before starting
  - Know the purpose of the grant
- Highlight the important details
- Review allowable and unallowable expenditures
- Answer the questions fully to identify your needs

- Research the cost of items
- Explain how students or the program will benefit
- Identify your timeline to complete the grant application
- Identify the deadline to use funds if awarded the grant





#### Perkins Reserve Grant Information

- School districts must apply first for Perkins to receive access to Perkins Reserve funds
- Review Perkins Reserve Eligibility Criteria – qualify in one or more areas
- Identify your gaps on Perkins performance indicators

- Match up Perkins performance indicators with use of funds
- Small rural schools are encouraged to fill out the application
- Funds potentially used to start new CTE programs
- End date to spend Perkins Reserve funds is by August 31





#### Perkins Reserve Grant Information

- Funds may NOT be used for food or any capital projects
- Connect to CTSO leadership opportunities
- Do not request more money than awarded by the grant
  - Ex: Don't ask for \$50,000 when the grant is only for \$30,000
- In multiple part questions answer all the parts

- Breakdown the costs of each item funds are used on
- Describe how many students will benefit from grant funds
- If grant benefits more than one CTSO, describe the need for each CTSO
- Highest need described should equal more money spent
- Funds must be specific for CTE, not paying for general items
