#### Continuous Improvement Framework

- Identification, provision, and growth of equitable supports within learning communities.
- Development of strong leadership at all levels.

- Focus on improving core instructional practices.
- Implementation within a multi-tiered system of supports.



#### Focus: Multilingual Education

The February Resource Toolkit is a focus on Multilingual Education. This toolkit is designed to empower educational leaders and instructors in schools that have been identified for improvement, particularly in addressing the unique needs of multilingual learners. In recognizing the importance of tailored strategies and goals, the following tools emphasize the development of effective approaches to meet the diverse needs of our students.

Washington State has approximately 145,000 students who are identified as multilingual learners. To help educators navigate the landscape of transitional bilingual instruction programs, also known as English language development programs, practices are implemented at the district level, guided by both state and federal laws, educational policies, and sound educational theory. Moreover, the toolkit underscores the importance of incorporating culturally responsive instructional practices to ensure the success and well-being of all multilingual learners.

Let this toolkit serve in fostering an inclusive and supportive learning environment for all students of varied linguistic backgrounds.
