What is Foundational Eligible for Cycle 3 WSIF Identification?

Schools identified in WSIF 2022 Cycle 2 as Tier 2, Tier 3, or Tier 3 Plus and identified for Foundational support in WSIF 2023 Cycle 3, are eligible to finish WSIF Cycle 2 for the 2024-25 school year at their WSIF Cycle 2 Identification. Schools in this category will automatically be included for 2024-25 supports as outlined in Option 1 below. If a school does not wish to maintain Cycle 2 supports, they will need to submit an opt-out form and complete an Exit Template as outlined in Option 2 below.
