

# "After-Exit" Running Start Declaration of Intent Form | Summer 2024

Pursuant to [Substitute Senate Bill 5187\(522\)\(2\)\(i\)](#), Class of 2024 students who have graduated high school by June and are within 15 credits of an associate degree may enroll in summer quarter Running Start. For graduating students, enrollment is limited to community and technical colleges and only the courses required to complete an associate degree, up to a maximum of 15 college credits. Non-graduating students who have met the 1.40 Annual Average Full-Time Equivalent (AAFTE) limit during the standard school year or non-graduating 5th year (or beyond) seniors who have reached maximum enrollment over multiple 12th grade years are also eligible and may enroll at any institution offering Running Start for a maximum of 10 college credits. Complete this form to verify each student's eligibility and ensure the graduation-eligible student's enrollment remains open until the end of the summer quarter.
