
**C. Zei cahren pawl (documents) nih dah na soal puhnak cu a bawmh? (Thimkhawh)**

Caan tha gap pawl a kharmi thil pawl le aa teltummi pawl caah OSPI nih aa zuam. Na fa ii chambaunak sining, chungkhar chungtel pawl ii miphun, le siangngakchia ii nu/pa sinak kong ah nangmah nih pumpek in konglam pek na duh a si ahcun kanmah nih kan ramkulh chung ah a cangmi pawl hliahnak ca lawng ah kan hman lai ii na konglam cu pumpak humhinnak in chiah a si lai. Kanma nih mah konglam cu rikhiahi chung in kan hman, siangngakchia silole chungkhar pumpak zehmanh he pehtlaih lo in, Washington sianginn pawl caah kan lam hruainak pehzulh in thancho ternak ding ah le siangngakchia le chungkhar pawl ii covo pawl bawmhnak thancho ter nak ding ah.

OSPI nih, a biapimi thil can ah, OSPI sin ah pekmi konglam (tch., email le a hlei in tuahmi fimcawnnak cahren pawl) cu a dang pumpak pawl, nawlgeitu pawl, silole federal silole ramkomh agency pawl sin ah Ahlei in Tuahmi Fimcawnnak Zatlangbu Lungtlinlonak (Special Education Community Complaint, SECC) hlathlai lio ah a pe lo.

Washington state's Public Records Act tang ah mah bantu konglam luhnak ding halnak cu mipi chungtel pawl nih an tuah khawh, a sinain mah halnak tuah a si caan chung ah, "luatternak" tampi a um. A dang in chim ahcun, mipi chungtel pawl nih an luh **lo** dingmi konglam phun tam pi an um. A biapimi ah, mipi record pawl halmi lehnak ding ah OSPI nih a tang lei konglam pawl h a pe lai **lo**:

- Sianginn riantuannak chung ii aa tlakmi minung pakhat, aa pehtlaimi konglam ah pumpak hngalhnak a ngei lo mi, nih siangngakchia cu ho dah a si timi a hliah ter kho tu pehtlaih ter khawhmi konglam. Tahchunnnhnak ah, na fa ii pum chambaunak silole miphun le miphun tengnge konglam.
- Konglam cu siangngakchia pumpak konglam langhternak ah a chuah a si ahcun chungkhar chungtel pale silole siangngakchia zohkhenh tu pawl caah pumpak konglam.
- Chungkhar chungtel pawl silole zohkhenhtu pawl ii laakruak pehtlaihnak konglam.
