### **Jekjen III: Ta ko emōj Nae Ruen – Ta eo kwōj tomak opij/bukon/jikuul ear bōd kake?**

**A. Melele eo am kin bōd eo/ko rejañin kamool:**

Kwōjab aikuj jela jejetin kakien eo emaron kar rupe; bōtab jouj im kalikar am kōmelele ta eo kwōj tomak opij/bukon/jikuul ear bōd kake, einwōt: "Rikaki ro rejab loore IEP eo an ajiri eo neju." Jouj im likūt peba ko elañe kwōj bar aikuj jikin jeje. OSPI emaron wōt etale abnōnō ko kōn bōd ko ilo special education im rekkar walok iloan iio eo jen raan eo rar loe abnōnō eo am. For example, if we receive the complaint on Oktoba 1, 2021, we can investigate a period starting on Oktoba 2, 2020.

Kim ej kōjermal melele ko emōj kakoba ibben doon, im ejab koba ñan jabdewōt juon rijikuul ak baamle, ñan amim woñmaanlok in kōkmanmanlok melele kein ñan jikuul ko ilo Washington im ñan kōkmanmanlok kōmadmōd ko rej jibañ maron ko an rijikuul im baamle ko.

OSPI ejab, einwōt juon wāween jermal, lelok melele (einwōt, email im peba ko kin special education) im OSPI ear lelok ilo ien madmōdin etale eo ikijen Abnōnō jen Jinen ak Jemen Rijikuul eo ilo Special Education (Special Education Community Complaint, SECC) ñan armij ro jet, opij ko, ak opij ko an federal ak state.

Armij ro ilobelej remaron kajjitōk aer loe melele kein iomwin kakien eo ñan lelok melele ilo ien ewōr kajjitōk (Public Records Act) an state eo an Washington, bōtab ilo ien emōj lelok kajjitōk, elōñ "kōmelim" ko ñan aer jab aikuj loor mennin aikuj. Ilo wāween ko jet, elōñ kain melele ko armij ro ilobelej **reban** maron loi. Auroktata, melele eo laajrak OSPI **eban** lelok ilo an uwaake kajjitōk eo ñan rekoot ko aoleb armij remaron loi:
