

- FPDs connect with Records Clerk and share your district grant application
- Enrollments should be processed as soon as possible
- All supplemental services on grant should be reported on MSIS
- MSIS uploads data to MSIX daily, we need to ensure we are meeting MSIX deadliness

### Reporting Enrollments

#### **Pending Enrollments**

- When new COE is identified in your district, Records Clerks receive email notification
- Pending COEs need to be processed as soon as possible
  - We have many pending COEs sitting for over 60 days
  - We need to ensure compliance with MSIX requirements


#### **Challenge COEs**







#### MEP Behavioral Health Grant 2023-2024

#### **DESCRIPTION:**

The Washington Migrant Education Program (MEP) is making federal funds available to participating school districts to help migratory children benefit from the introduction or expansion of high-quality behavioral health programs and services. The introduction or expansion of behavioral health programs and services must:

- 1. Address specific behavioral health needs of local educational agencies' migratory eligible students; and
- 2. Be supplemental to existing local, state, federal, or other
- 3. In alignment with the MEP State Service Delivery Plan activities and services.

Funds will be available in five different block grant opportunities depending on the level of need, migratory student count, and program(s)/services proposed.

#### **ELIGIBILITY:**

Eligible Applicants: Existing or new local school districts accepting a Title I, Part C. Migrant Education Regular Grant

Additional Information on Eligibility: Participating Title I, Part C school districts with carryover less than \$450,000.00

#### **Priority:**

Priority will be given to districts based on the following criteria:

### Grant applications for 2024-2025, Year-2

For Approved Applications:

- Initial goal must remain the same
- You may use the previous years proposal and data to continue local efforts.
  - Previous years data must inform OSPI how it will continue to improve on the initial identified need.
- Previous grant proposal may be adjusted to reflect new/modified activities and funds based on need.
  - Previous years data must support initial proposal amendments to activities and funds, including PAC consultation.



### Applications will be evaluated by partner ESDs and OSPI. For a successful application, consider the following:

Quality vs Quantity: The activity does not drive the need.

- Proposed Activities- do they address an <u>identified</u> behavioral health need?
  - How did you identify the specific behavioral health need? What tool did you use?
  - Do the activities proposed by PAC, youth, and families directly address the identified need?
  - Is the activity addressing a behavioral health need directly or tangentially? Is it feasible?
- Budgeting- Is it itemized, clear, necessary, reasonable, and allocable?
  - Purchase of "supplies", leasing vehicles instead of purchase, collective cost in consortia.



### For Example:

PAC is recommending funding a soccer club due to lack of physical activity.

- Proposed Activities- Is this an <u>identified behavioral</u> health need?
  - No, the proposal noted that this activity was suggested due to physical activity,
    - How was the specific behavioral health need identified? PAC made the recommendation.
    - What tool did you use? A survey have been conducted but this need is not specific to behavioral health.
    - Is the activity addressing a behavioral health need directly or tangentially? No, the need identified is specific to lack of physical activity.
    - Is the activity targeted to needs students? No, no evidence of how youth with specific behavioral health needs are recruited or if this activity specifically meet their needs.



### Applications will be evaluated by partner ESDs and OSPI. For a successful application, consider the following:

### **Quality vs Quantity:**

- # of proposed activities- can be they implemented and managed effectively?
  - More is not always better, consider consolidating for a targeted intervention
- PAC Consultation- did you submit evidence of consultation? (not just summary)
  - Agendas, pictures, notes, follow-up meetings, etc.

#### Math & Science Academic Academies

- The purpose of this program is to provide Priority for Service migratory students with access to professional staff who will help students build their skills and abilities in the areas of math or science as well as develop students' awareness of the requirements to graduate high school and plan for postsecondary education or employment. This program is in-person on a university campus.
- The Math and Science Academic Academies are intended for 11th and 12th grade migratory students. Those who successfully participate and complete required work for the academy they attend will earn .5 credit in science or math.

- Additionally, migratory students who wish to participate in this program must meet these requirements:
  - ✓ A 3.2 or higher GPA OR demonstrate the ability to be academically successful.
  - ✓ Taken at least one (1) advance course in biology, chemistry, math, etc.
  - ✓ Plan to pursue a post-secondary education.
  - ✓ Demonstrated interest in pursuing a career in the health sciences.





Enrique Cerna worked in Seattle media for more than four decades. You may recognize him from his work as a reporter, producer and host for KOMO Radio and Television, KING Television and KCTS Public Television.



# Local Summer Programs - EGMS



## Reporting in the Migrant Student Information System and EGMS (Regular Year)

- Ensure all identified eligible students are enrolled in MSIS.
- Any students who are no longer enrolled in school but are still in your community should be noted as Out-of-School (OSY).
- Students with 20-days or more absences should be reviewed to determine if they should be identified as OSY.
- Report services provided with Migrant Education Program funds in the individual student record.
- Review services reported in MSIS against the approved grant application to ensure data matches and is close to the projected number of students to be served.
