BACKGROUND

State and federal law prohibits discrimination in Washington public schools on the basis of national origin, which includes limited-English proficiency (LEP). Under these laws, school districts must ensure meaningful communication with parents and guardians in a language they can understand and adequately notify them of information about any program, service, or activity of the school district that is called to the attention of non-LEP parents. (RCW 28A.642.010 and Title VI of the Civil Rights Act of 1964).

To support LEAs with this requirement, the Office of Superintendent of Public Instruction (OSPI) has purchased access to pre-translated forms through TransACT ParentNotices.

TransACT ParentNotices provides Washington LEAs with unlimited access to online collections. These are designed to meet federal requirements within the collections of Every Student Succeeds Act (ESSA), general education, Individuals with Disabilities Education Act (IDEA), and 504 collections in multiple languages. OSPI has ensured the top ten languages will be available on June 30th. These languages include:

- English
- Russian
- Ukrainian

- Chinese-
- Korean
- Somali
- Vietnamese

- Mandarin
- Punjabi
- Spanish

To sign up for a <u>free</u> account:

- Go to the <u>ParentNotices Self-Onboarding link</u>
- Enter your school district email address and click the green "Validate" button
- Make sure your school district is listed, then enter your first and last name, name of school, and 'Title' you should ignore other fields at this time
- Click submit, and your account is created
- You'll receive an email asking you to create and confirm a password
- Once you do this, you can log in to ParentNotices and start exploring
