

# *OSPI Child and Adult Care Food Program Checklist*

## **Fiscal Year 2024–25 Training Checklist**

As a Child and Adult Care Food Program (CACFP) sponsor, you must certify completion of all training requirements when submitting your sponsor application. Use this checklist as a guide to complete Fiscal Year 2024–25 (FY25) training requirements. You do not need to return this form. This training is mandatory; FY25 renewal applications will not be approved until the appropriate person has attended training.

### **Who Must Attend Annual Training?**

- All institutions participating in the CACFP.
- All institutions planning to participate in the CACFP in FY25.
- At a minimum, the person responsible for oversight of the CACFP must attend. This training is intended for directors and administrators.

### **How to Participate in Annual Training**

Training will be provided as recorded training modules in Canvas, OSPI's learning platform. Training information can be found on the [CACFP Training webpage](#). Please select the appropriate dropdown, based on your organization type, to access required trainings.

### **Certificate of Training Completion**

You must certify completion of required training in Canvas. Instructions for this process will be provided at the end of your Canvas course(s). Save this documentation with your CACFP records. You do not need to submit this to OSPI.
