


All students prepared for post-secondary pathways, careers, and civic engagement.

To-Do List




- End of year letters
- Update and complete trainings
- Update contact information
- Order posters and brochures for fall
- Prepare your unaccompanied homeless youth
- Be sure all unaccompanied homeless seniors have their verification letter for financial aid
- Begin verifying data for August OSPI reporting



- Provide students and families with outside partnership information
 - Food pantries
 - Free lunch sites
 - Free activities (library, community centers, and more)
- Remind families to reach out if their housing situation changes







- Remind school staff that all students follow their feeder pattern
 - If housed Elementary School "A" students go into Middle School "A," so do students who qualify under MV.



- Review and update district polices and procedure (Policy 3115, Process 3115P)
- Remind office staff not to withdrawal students
- Provide a summer contact number and email to students and families








Summer School/Credit Recovery:

LEAs must ensure that homeless children and youths who meet the eligibility criteria do not face barriers to accessing academic and extracurricular activities, including **summer school**. (42 U.S.C. § 11432 [g][1][F][iii]) If participation in summer school is limited, homeless students must be given preference. If a homeless student cannot participate in summer school without transportation, the LEA must arrange transportation.



Reminder: McKinney-Vento Students KEEP Their Eligibility When the School Year Ends

McKinney-Vento eligibility remains in place for the duration of homelessness (per federal law) and students should not be exited or have their status changed at the end of the school year.

- The end of the school year does not end a student's eligibility or qualification for services under McKinney-Vento.
- No homeless student should lose their MV eligibility unless they have un-enrolled from the district or the liaison has solid information that the student has become permanently housed over the summer.
- McKinney-Vento students retain their homeless status throughout the full year, over the summer and into the following school year.
- Next fall when housing questionnaires are disseminated, the district can determine if any student should be exited from the program based on their housing status, individual best interest determinations, etc.



Eligibility When the School Year Ends, Cont.

- If the district's SIS (Student Information System) automatically removes homeless students at the end of a business year, the district has a responsibility to re-enter those students into their SIS immediately to ensure continuity of services until such time the district can verify that the student no longer meets the MV definition of homeless.
- It is best practice to reach out to your families now, and over the summer, to ensure students are identified and have a smooth transition to school in the fall. A <u>customizable sample letter</u> to families is posted to the OSPI Homeless Education website.





