Waalidka Qaaliga:

Xaruntayadu kama qaado lacag gaara cuntooyinka waay wuxuu ka qeybqaatahaa Barnaamijka U.S. Department of Agriculture (USDA) Daryeelka Cunuga iyo Dadka Waaweyn (CACFP). Barnaamijkani wuxuu lacag siinayaa cuntooyinka nafaqada leh ee la siiyo dhamaan caruurta daryeelka.

Intee inleeg ayaa xaruntu bixisaa lacagaha cuntooyinka la siiyo cunugayga daryeelka ku jira?

Xadiga lacagta la helo wuxuu ku saleysan yahay xaalada dakhliga qoysaska xarunteena. Waxaan u helnaa lacag badan qoysaska dakhligoodu hooseeyo.

Sideed u go'aamisaa xaalada dakhliga qoyskayga?

Macluumaadka aad ku sheegtid Diwaangalinta/Codsiga Ku Haboonaanshaha Dakhliga ayaa go'aamiya xaalada dakhliga iyo heerka lacag bixinta.

Ma hubo haddii dakhliga qoyskaygu ku haboonaan yahay. Sideen u go'aamiyaa?

Haddii dakhligaaga guud (ka hor intaan wax laga jarin) la mid yahay ama ka yar yahay xadiga khadka xajmiga qoyska ee tilmaamaha jaantuska hoose ee dakhliga, xaruntu waxay ku haboon lacag bixin badan oo cunugaaga (caruurtaada). Haa. DSHS lacag bixinta daryeelka cunuga ma qanayso qoyska.

Haddii dakhligayga qoysku ka badan yahay dakhliga tilmaamaha cuntooyinka qiimaha jaban, ama aan doorto inaanan sheegin dakhligayga, maxaan sameeyaa?Waa inaad dhameystirtaa Qeybaha 1 iyo 5 oo aad ku qortaa "cabir sare" Qeybta 4.

Haddii aan doorto inaanan sheegin dakhliga qoyskayga, miyaan u baahanay inaan soo celiyo Diwaangalinta/Codsiga Ku Haboonaanshaha Dakhliga?

Haa. Haddii aad dooratid inaanad buuxin qeybta dakhliga Diwaangalinta/Codsiga ku Haboonaanshaha Dakhliga (E/IEA), waa inaad wali dhameystirtaa Qeybta 1, qeybta "Macluumaadka Caruurta", iyo Qeybta 5. Shuruucda fadaraalka ayaa u baahan in dhamaan xarumaha daryeelka cunugu helaan macluumaadka maalmaha caadiga ah iyo saacadaha cunuga(caruurta) ayaa la filayaa in la daryeelo iyo cuntooyinka la filayo in la helo.

Miyuu jiraa hab kale oo xaruntu ku heli karto lacag ka badan tandakhliga qoyskaygu isticmaalayo?

Haa. Cunugaaga(caruurta) waxay ugu haboonaan karaan lacag badan mid ka mida sababan soo socda:

1. Waxaad heshaa cuntada Asaasiga ah, Caawimada ku meelgaarka ah ee Qoysaska Baahan (TANF), ama Qaybinta Cuntada ee Siinta Hindida (FDPIR), xubinkasta oo qoyskaga ah.
2. Cunugaagu waa la xanaaneynayaa.

Haddii xubin qoyska ah helayso kabka mid ka mida barnaamijyadan, ama aan aamisanahay dakhliga qoyskayga uu ku haboonaan doonaa cunugayga, maxaan sameeyaa?

Dhameystir Diwaangalinta/codsiga Ku Haboonaanshaha Dakhliga ku lifaaqan, tilmaamahan soo socda ee foomka. Waxa jirta qeyb gaara dhanka cunugaagu ku haboonaan karo.

Miyaa macluumaadkani la asturayaa?

Haa. Macluumaadka waxa heli doonaa kaliya tiro kooban oo shaqaalaha ama shaqaalaha Xafiiska Kormeeraha Guud ee Waxbarashada Dadweynaha, U.S. Department of Agriculture, ama Xafiiska Xisaabaadka Guud ee Mareykanka markay dibu eegayaan barnaamijkeena.

Miyaa xaruntu u sameyn doontaa badelka cunugayga?

Haddii cunugaaga uu go'aamiyey dhakhtar inuu naafo yahay, oo naafadu ka hor istaagayso cunista cunto caadiya xarunta dhexdeeda, waxaanu sameyn doonaa badelka uu qoray dhakhtar oo bilaasha.

Maxaan u baahanay inaan keeno xarunta haddii cunugaygu u baahan yahay badelka?

What is the CACFP?

The Child and Adult Care Food Program (CACFP) is one of several United States Department of Agriculture (USDA) nutrition programs providing federal reimbursement to nonresidential child and adult care centers to serve nutritious meals and snacks.

USDA provides federal oversight, develops regulations and guidance to ensure federal laws are followed, and provides meal reimbursement.

The program is administered by Child Nutrition Services in the Office of Superintendent of Public Instruction (OSPI) in Olympia, Washington.

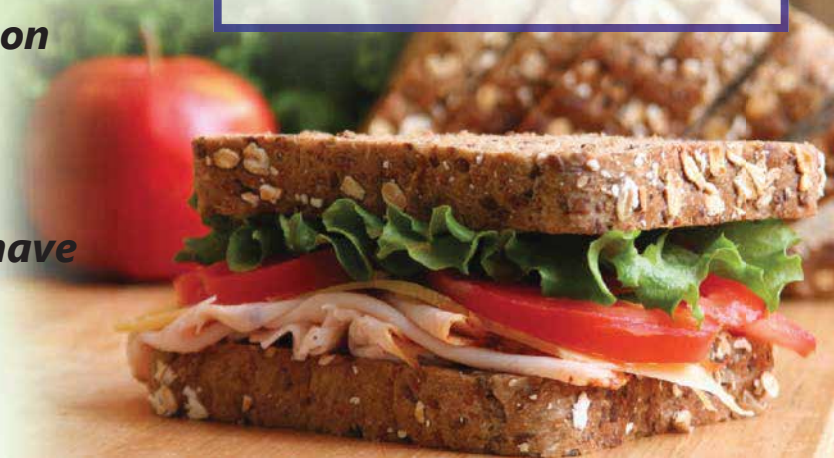

FIRST CLASS

How does the CACFP work?

The CACFP provides reimbursement for meals served to children in child care centers, family day care homes, at-risk centers, homeless shelters, and certain adult care centers. Meals must meet basic program requirements.

What are the Benefits?

These federal funds help centers offset food costs while providing well-balanced, nutritious meals and snacks to enrolled participants.

Who can participate?

All enrolled individuals at centers approved to operate CACFP.

Child Care Center

Child care centers must be licensed by the Department of Early Learning (DEL), tribal authority, or the military. For-profit (proprietary), licensed child care centers may participate if 25 percent of their licensed or enrolled capacity, whichever is less, are eligible for free or reduced-price meals.

Adult Care Center

Adult care centers may be nonprofit or, if for profit, must be receiving compensation under Title XIX for at least 25 percent of the participants. Washington State has additional eligibility requirements for participation.

Family Day Care Homes

Family day care homes must be licensed. Family day care providers in a licensed home must operate under a Family Day Care Home (FDCH) sponsoring organization.

Legally exempt unlicensed family day care providers approved by DSHS to provide relative care in the provider's home may participate under a sponsoring organization.

At-Risk Centers

At-risk centers must provide educational and enrichment activities to at-risk students in low-income areas. Only after-school snacks are eligible for reimbursement under this option. At-risk centers must meet state safety and health standards and have a current fire permit.

Homeless Shelter

Homeless shelters must be nonprofit, meet state safety and health standards, and have a current fire permit. The site must provide temporary shelter.

State Agency oversight

Federal regulations require that centers enter into an agreement with OSPI, Child Nutrition Services.

Centers must keep all or some of the following records: child and adult enrollment, free and reduced-price meal eligibility, attendance, number of meals served, and menus for meals served. Centers are financially responsible for all expenditures and incomes for this program and must operate a nonprofit food service.

How does this center get reimbursed?

Federal moneys pay some of the costs to prepare and serve meals that meet the USDA meal patterns.

Centers are paid at federally published rates according to the income level of families served.

At-risk centers receive reimbursement only for after-school snacks served during the school year. All snacks are reimbursed at the free rate.

Homeless shelters are reimbursed for all meals at the free rate.

Family day care providers are paid by their FDCH sponsoring organization. Family day care providers are reimbursed based on specific eligibility guidelines.
