Requesting a waiver in the POM

FNS has completed review of the Washington 2024 Plan for Operations and Management (POM). FNS has determined that Washington must submit a request seeking waiver approval in order to administer the Summer EBT as planned. FNS has authority to waive regulatory provisions for Summer EBT, when certain conditions are met, consistent with Section 12(l) of the Richard B. Russell National School Lunch Act, 42 U.S.C. 1760(l). For more information on the process for requesting waivers, please refer to, May 24, 2018.

In order to review and determine if requested waiver(s) may be approved, FNS requires provision of the following information, which may be added as an attachment to Washington's 2024 POM.

Describe the challenges the Summer EBT agency is seeking to solve with the requested waiver(s), including the goal of the requested waiver(s), the manner in which the requested waiver(s) will improve services in Summer EBT, and the expected outcomes if the waiver(s) are approved:

Washington state's Department of Social and Health Services (DSHS) is finalizing Data Share Agreements (DSAs) to with our partners at the Office of the Superintendent of Public Instruction (OSPI) to verify enrollment in SUN Bucks qualified schools for applicant families. We are also uploading final files from eleven remaining schools for automatic enrollment and benefit

issuance. 7 CFR 292.12 and 292.13 require that applicant families must be notified of eligibility within 15 days from the date of application, and that incomplete applications be acted on within 10 days. We are also developing a process for verification for cause for paper applications; our third-party vendor Accenture has safeguards in place preventing incomplete online applications. While we strive to meet these timelines, this waiver would provide a safety net ensuring we stay in compliance with federal regulations while we work to solidify the process seamlessly.

Describe steps the Summer EBT agency has taken to address barriers at the State level:

DSHS, our third-party contractor Accenture, LLP, and education partners at OSPI have developed an application process that becomes available to families effective July 1, 2024. We are also working with our EBT vendor, FIS, to plan issuance dates for final school uploads the first week of July 2024, and finalizing DSAs between agencies for a validation process for applicant families. This waiver protects in the event issuances are delayed for any reason.

Describe anticipated challenges the Summer EBT agency may face if the requested waivers are not approved:

If this waiver is not approved, and SUN Bucks issuance dates are not met, Washington DSHS will be out of compliance with federal regulations.

Describe the expected waiver implementation date and time period:

Implementation dates for this waiver will cover dates in which SUN Bucks benefits for the summer period following the 2023-2024 school year are authorized. June 1 – September 30, 2024.
