EOGOAC Annual Report (February 2024) RCW 28A.300.477

Attendees reviewed recommendation 7 within the Educational Opportunity Gap Oversight and Accountability Committee (EOGOAC) Annual Report published in February 2024 and discussed opportunities to work together. Per RCW 28A.300.477, in addition to other meetings, "the committee shall have a joint meeting once a year with the educational opportunity gap oversight and accountability committee." The date is to be determined but we are planning for late October and will tentatively be in-person.

Debra Parker asked if there were volunteers who would like to join the planning committee for this joint meeting with EOGOAC members. Xyzlora Brownell, Sarah Butcher, Amy Drake, and Suzie Henning volunteered, with Caryn Park as an alternate. The planning committee meeting dates are tentative: July 24 or 25, and sometime in August-October before the meeting.

SEL Standards, Benchmarks, and Indicators

Debra Parker led us in a six-step brainstorming process by first grounding us in SELAC's three focus areas: family and community engagement, SEL implementation evaluation, and SEL assessment. The goals for the activity were to organize the Committee's work, identify advocacy opportunities, and identify improvement cycles.

Step 1: Identify 4 SEL Thoughts or Needs

• Consider the role you represent on the Advisory, the work you do, and your



values

- Write out 3 thoughts or needs as they relate to the Focus Areas
- Write one additional topic or need not directly related to the Focus Areas

Step 2: Small Group Share

- Form groups of 3 or 4 and share your thoughts/needs
- Find commonalities, provide feedback, and be open to questions
- Add refined thoughts/needs to chart paper

Step 3: Gallery Walk

Perform a gallery walk to look at the other charts.

Mark items that you like and items that you have questions or concerns about.

Step 4: Small Group Sorting

Tammy Bolen, Xyzlora Brownell, Caryn Park, and Leiani Sherwin consolidated/chunked out the thoughts/needs into themes. They identified the following themes:

- Evaluation
- Data & what we do with it
- Adult Capacity Building
- Funding and supporting anything we require
- Accountability
- Voices & Stories
- Leadership
- Family & Community Engagement
- Cross-System Engagement
- Assessment
- Advocacy with Legislature

While Tammy, Xyzlora, Caryn, and Leiani looked for themes, other participants reviewed documents at four stations to identify key ideas, provide input on ways to improve, and ask questions. Documents reviewed included the <u>SEL implementation guide</u>; OSPI <u>SEL briefs</u>; <u>SEL Standards, Benchmarks, and Indicators</u>; and assorted SEL Assessment guidance documents.

Step 5: Equity Lens Check


Utilizing questions from the PSESD Racial Equity Tool, how do the cluster of needs and considerations we identified:



- Foster greater participation in schools and communities and promote family and community leadership?
- Clearly document existing inequities and service gaps?
- Point to specific goals and measures of accountability for decreasing racial inequity, including systemic inequity?
- Keep pace with changing community needs and demographics?
- Improve SEL access for ethnically diverse communities, including immigrants and refugees?

Step 6: Identify Monthly Themes

Caryn and Xyzlora led us through a process of identifying themes for each month that SELAC will meet in the upcoming year, starting with the calendar below indicating that SELAC would not be meeting in December or July.



August

- ESDs: share SELAC recommendations with them at board meetings (get on agenda or do a public comment)
 - Are there opportunities to deliver SEL PD through the ESDs?
- SBE: get on the agenda to present the SELAC recommendations
- Participate in community engagement opportunities around the state to ensure an SEL perspective is recognized (also able to do online)



Virtual or in-person public comment at every meeting

September

 Host a virtual convening and debrief on the new report recommendations (also in November)

October

 Prepare talking points for organizations on SEL legislative priorities (also in January)

November

- 2025 Advocacy Day
- Student Voice

January

- Prepare talking points for organizations on SEL legislative priorities
 SELAC members should educate all incoming members on the committee and recommendations
- Follow WA state PTA action alerts that track SEL related bills, send messages to lawmakers, follow the WA state PTA blog for updates

February

- WASFEC (Washington Family Engagement Center) can partner in an SEL focused event to inform families
- HCA weekly roundtables

March

- SEL Day!
- Advocacy could include working with WEA/educators
- SEL Day Contest: students could write an essay, do a performance, create a video or other artistic project related to SEL. Interested in highlighting Student Voice. Could there be an student competition around this?

April

Recruit WSSDA, AWSP, WERA, and WASA leaders to join SELAC



May

 Share the SELAC report out to advocacy organizations like: EEC, LEU, Stand for Children, College Success foundation

June

- Professional Development Day success stories
- Community events

- January-April, add a regular legislative update to SELAC meetings
