SSB 5072 Highly Capable Students

Statutory and/or Budget Language

\$76,000 of the general fund—state appropriation for fiscal year 2024 and \$15,000 of the general fund—state appropriation for fiscal year 2025 are provided solely for implementation of Substitute Senate Bill No. 5072 (highly capable students).

Purpose

Data about numbers of identified Highly Capable students for every Washington State LEA is to be publicly available and posted on the OSPI website to be updated annually. All student datarelated reports required of the superintendent of public instruction in this title must be disaggregated by at least the following subgroups of students: White, Black, Hispanic, American Indian/Alaskan Native, Asian, Pacific Islander/Hawaiian Native, low income, highly capable, transitional bilingual, migrant, special education, and students covered by section 504 of the federal rehabilitation act of 1973, as amended (29 U.S.C. Sec. 794).

Description of Services Provided

Data analyst position was assigned to this project at 0.5 FTE. Starting in November 2023 these Highly Capable student data were posted on the OSPI Highly Capable webpage in an <u>Excel</u> <u>spreadsheet</u>. It is to be updated annually.

Criteria for Receiving Services and/or Grants

SSB 5072 does not include grants or other direct funding to local districts.
