### **Students**

FlexPoint Virtual School is open to all students in grades K-12. All students are welcome! We have advanced courses, core courses, electives, and credit recovery. We serve both part time and full time students, elementary through high school.

### **Student-Teacher Contact Requirements**

FlexPoint Virtual School courses are designed to take a semester (or 18 weeks) per 0.5 credit. Depending on the instructional model, students can work faster or take more time in the courses. All FlexPoint Virtual School courses come with individual pace planners so teachers and students can work together to determine the best pace for each student. There are required discussion-based assessments in all courses, monthly parent/student/teacher progress contact, and collaboration requirements. However, our entire program is run asynchronously with opportunities to attend live lessons and synchronous sessions. Teachers are available to students seven days a week for real time calls, chats, texts, or webinars. There is a requirement for students to submit assignments every week unless other arrangements have been made with their instructor.

### **Courseware Platform**

FlexPoint Virtual School uses the Educator learning management system. Students will access their courseware, do their work, communicate with teachers via email, and monitor their grades via Educator.

We also use a student information system called Virtual School Administrator (VSA). This system tracks data, phone calls, emails, grades, and student information. When students log in to their courses, VSA is the launching point into Educator, the LMS. Outside school administrators and parents also can use VSA to monitor student progress.
