2025–26 Assurances

Important Information

- ✓ The commitments outlined in the Assurances must be read, agreed upon, and signed by the Fellow, their district, building, or program leadership, or their principal.
- ✓ Signed Assurances need to be attached to an application to submit for participation as a 2025–26 Fellow.
- ✓ Applications are due October 31, 2025. Applications are accepted throughout the school year, but most Fellows sessions start in October or November.

Fellows Commitments

Professional Learning Convenings

Professional Learning sessions may be offered face-to-face, virtually, or using a hybrid approach. All Fellows will attend a minimum of four 1-day regional convenings.

New Fellows

- Attend and participate in a required New Fellows' Orientation before first content area convening.

Participation

- Submit a completed New and Returning Fellows Application.
 - Signed Assurances must be uploaded to apply.
- Attend a minimum of four 1-day regional convenings during the 2025–26 school year.
- In the 2025–26 school year, the Fellow will develop an Action Plan in partnership with their school leadership. The Action Plan outlines how the Fellow's leadership will support implementation efforts within the district, school, and/or community for the Washington State Learning Standards.
- Engage in providing data that could include but is not limited to, student work samples, participation surveys, formative assessment data, the sphere of impact, etc.

District or Program Leadership and Principal Commitments

- District/program administration and/or principals will support the Fellow(s) and utilize their leadership within existing learning opportunities for teachers.
- The Fellow, district/program leadership, and the principal must collaboratively review and sign the Assurances.
- Support the travel and substitute costs for the Fellow(s) to attend and participate in a minimum of four 1-day regional professional learning convenings.
