Substitute Senate Bill 5030

- The Washington School Counselor Association (WSCA) has been working for years to legally clarify the role of a School Counselor
- As a result, in the 2021 legislative year, SSB 5030 was passed, requiring school districts across the state to develop a comprehensive school counseling program (CSCP) that will be implemented in each school.
- CSCPs must address the students social/emotional, career, and academic needs and be implemented in alignment with the American School Counselor Association (ASCA) National Model.

4 Required Components to SSB 5030

- 1. Alignment with Washington State & National Standards
- 2. Provide a process for identifying students needs
- 3. Explain how direct & indirect services will be delivered
- 4. Establish an annual review & assessment process

Currently

The Newport School District School Counselors have collaborated and developed a district wide, comprehensive school counseling program to be implemented in each building. We are seeking board approval to implement this CSCP in the Fall of 2022.

The following slides outline our plan & highlights how each essential component will be addressed.

#1 - Alignment with WA State & National Standards

The Newport School District Comprehensive School Counseling Program was developed in alignment with the American School Counselor Association's MIndsets & Behaviors for Student Success and Washington's OSPI SEL Standards. *Appendix B & D*

The implementation of these standards will include all school counselors in the districts addressing the social/emotional, career, and academic needs of our students at a developmentally appropriate level. **Page 6**

#2 Provide a Process for Identifying Student Needs

- In implementing our CSCP in each building Fall 2022, data will be collected and analyzed to better understand the specific needs of our students. This will guide the services delivered. See next slide & page 6 of handout
- To ensure accountability, school counselors will maintain data on their program results as well. This data will guide us in understanding the gaps in our programs and what needs to be altered to better serve our students

- The Newport School counselors will be using SCUTA to track our use of time.

- Communication with Stakeholders will be considered in the development of CSCP services as well.

#3 Explain how Direct & Indirect Services will be Delivered

Direct and Indirect services will be delivered through a Multi-Tiered System of Supports with evidence-based practices and communication with all stakeholders. SSB 5030 states that 80% of school counselor's time should be spend delivering direct & indirect services. *Page 9*

#4 Establish Annual Review & Assessment Process

- NSD School counselors will engage in regular assessment of their counseling program and the impact of their services for students.
- Results from these assessments will be reviewed with principals annually, or as often as the Administration-Counselor Team see fit
