## 2025–26 Program Review Local Education Agency (LEA) Selection

## **LEA Selection Process for Participation in Program Review**

OSPI used a risk or needs-based selection process through the Annual Program Review & Support Risk Assessment. LEAs with the highest risk assessment score were selected to participate in Program Review.

The Annual Program Review & Support Risk Assessment is based on the following available data and weighted, highest to lowest, in the following order:

- 1. Last time the LEA participated in Program Review (formerly CPR)
- 2. Percentage of schools identified for Comprehensive Supports as part of the Washington State Improvement Framework (WSIF)
- 3. Sum of federal ESEA funds
- 4. Items not fully implemented in previous Program Review (formerly CPR)
- 5. Elementary and Secondary Education Act (ESEA) program data

Charter Schools and State-Tribal Education Compact Schools are selected by a modified selection process. In the second and fourth years of operation or participation, the school will be selected to participate in a Program Review. In the following years, they are selected in the same manner as the districts.

To better support LEAs through the Program Review process, we are continuing our differentiation of the number of programs reviewed based on the size of the LEA. LEAs with fewer than 1000 students enrolled, will receive a review of no more than three (3) applicable programs. LEAs with 1000 to 3499 students enrolled will receive a review of no more than six (6) applicable programs. Finally, LEAs with 3500 or more students enrolled will receive a review of all applicable programs. Program selection is based on LEA funding, the last time the program was reviewed, internal program priorities, and internal program staff capacity.
