EXECUTIVE SUMMARY

House Bill 1664 (2022) increased allocations for specific types of personnel in the prototypical school funding model. HB 1664 also required that funding, up to the combined minimum allocations, for nurses, social workers, psychologists, counselors, classified staff providing student and staff safety, and parent involvement coordinators through the prototypical school funding model may be allocated only to the extent of and proportionate to a school district's demonstrated actual ratios of full-time equivalent physical, social, and emotional support staff (PSES staff) to full-time equivalent students.

In accordance with RCW 28A.300.476, the Office of Superintendent of Public Instruction (OSPI) must submit to the appropriate committees of the legislature biennially a report analyzing the implementation of RCW 28A.150.260 (5)(b), related to physical, social, and emotional support staff. This report must be completed in 2025, 2027, and 2029. This requirement expires after the 2029 biennial report.

INTRODUCTION

The 2022 legislature passed House Bill 1664 (HB 1664), which increased allocations for specific types of personnel in the prototypical school funding model. HB 1664 also required that funding, up to the combined minimum allocations, for nurses, social workers, psychologists, counselors, classified staff providing student and staff safety, and parent involvement coordinators through the prototypical school funding model may be allocated only to the extent of and proportionate to a school district's demonstrated actual ratios of full-time equivalent physical, social, and emotional support staff (PSES staff) to full-time equivalent students.

"Physical, social, and emotional support staff" include nurses, social workers, psychologists, counselors, classified staff providing student and staff safety, parent involvement coordinators, and other school district employees and contractors who provide physical, social, and emotional support to students as defined by the Superintendent of Public Instruction (SPI). OSPI established rules in WAC 392-122-440 that further defines which staff can be included in districts' calculations for PSES compliance. School districts are required to prioritize funding allocated for PSES staff who hold a valid educational staff associate (ESA) certificate appropriate for the staff's role.

STATUS

As of the date of this report, data is still preliminary for SY 2024–25. As of March 1, 2025, OSPI estimates an approximate 5,403.853 full-time equivalent (FTE) physical, social, emotional, and support staff allocation for school year 2024–25. Statewide, local education agencies reported a total of 6,963.21 FTEs serving students in these PSES roles.
