ESEA and Title I Flexibilities; Feedback	<p>Alyssa Ibanez continued the federal funding discussion, noting OSPI's goal to provide support on how LEAs can best use Title I funds for the greatest outcome.</p> <p>Feedback– Every year it becomes more difficult to exercise full flexibility in supporting well rounded education. Funding reductions/gaps cause difficulty with supporting enrichment because funds need to be primarily used for crisis support. Confusion over definition differences for Supplement-Not-Supplant (SNS). Clarification would be helpful to prioritize needs. SNS is a challenge for high poverty due to Yes/No eligibility instead of a sliding scale.</p>	NA
