## New Enrollment Reporting Rules for Competency Based Programs

Competency-based programs will have new enrollment rules established based on Senate Bill 5189. Under these rules, <u>only those</u> schools that are part of the mastery-based learning collaborative or have a current waiver from credit based graduation requirements will have new choices for enrollment reporting. These choices will also have funding implications. The emergency rules and additional guidance will be distributed before September 1.

### **Apportionment System Update**

The Legislature has approved a complete redesign of our apportionment systems, including the P-223, Apportionment, F-195, F-195F, F-200, F-196, S-275, F-203, and other online School Apportionment and Financial Services online collection, calculation, and reporting tools. Vendors will be selected this school year, development will begin in 2026-27, and we are targeting full implementation by the 2028-29 school year. Earlier implementation of some elements may occur earlier.
