Child and Adult Care Food Program Reference Sheet for Family Day Care Homes

Tiering

The tier level of each Family Day Care Home determines the rate of reimbursement the home receives for meals served. It is the responsibility of the Sponsoring Organization to correctly tier each of their providers.

There are four Tiering Classifications

- **Tier I** day care homes receive the **high** meal reimbursement rates for all children. The provider either lives in a low-income area as determined by school or census data or is determined a low-income family based on their submitted Provider Income-Eligibility Application.
- **Tier II High** day care homes receive the **high** meal reimbursement rates for all children. The provider is not low-income and does not live in a low-income area, but all the children are determined low-income based on their submitted Tier II Family Income-Eligibility Applications.
- Tier II Low day care homes receive the low meal reimbursement rates for all children.
 Neither the provider nor any of the children are determined low-income nor does the provider live in a low-income area.
- **Tier II Mixed** day care homes receive a combination of **high and low** meal reimbursement rates. The provider is not low-income and does not live in a low-income area but one or more of the children are determined low-income based on their submitted Tier II Family Income-Eligibility Applications.

Determination of Tiering Level

Tiering is determined by School Data, Census Data or Income-Eligibility Applications.

School Data-Used to Qualify Tier I Homes

 The Area Eligibility list is used to determine if any schools (elementary, middle or high school) that serve the family day care home address have at least 50% or more of the enrolled children are eligible for free or reduced-price meals (at or below 185% of the federal poverty guidelines).

Census Data- Used to Qualify Tier I Homes

 Census block groups (CBG) are the geographical units used to assess the eligibility for the CACFP. For a day care home to be eligible, 50% or more of the

children in a CBG must be eligible for free or reduced-price meals. Census data can be accessed on the <u>USDA CACFP and SFSP Area Eligibility Mapper</u> or the <u>Share Our Strength Averaged Eligibility Map</u>.

Provider Income-Eligibility Application-Used to Qualify Tier I Homes

 A provider may complete a Provider Income-Eligibility Application to show that they are low income. Current versions of these forms can be found on the <u>Family Day Care Home Providers/ Sponsors webpage</u>, under Tiering Resources.

Family Income-Eligibility Application-Used to Qualify Tier II High and Tier II Mixed Homes

 A provider may choose to have all or some of the families of the children in care complete Family Income Eligibility Applications to set the tiering rate of reimbursement.
