



## Child and Adult Care Food Program Monthly Participant Attendance & Eligibility Report

## **Instructions for Completing the Monthly Participant Attendance & Eligibility Report:**

Once the month has ended, enter the following information in each column:

1) Use Institution's completed monthly consolidated attendance reports to list the **names of every participant in attendance during the month** (last name first).

Using the Participant Eligibility Roster:

- 2) Enter the **EIEA effective date** for each participant listed. EIEAs are effective for 1 year, through the last day of the effective month. If the participant is categorically eligible based on Head Start or ECEAP enrollment list the date of program enrollment.
- 3) Enter the participant's category of eligibility.

After the above information has been entered:

- ✓ Calculate the **Total Attendance** on each page.
- ✓ Calculate the **total number of free, reduced price and above scale** (F/RP/AS) participants on each page.
- ✓ Transfer Total Attendance and Total of F/RP/AS from each page to the **Monthly Summary** on the last page and calculate the **Grand Totals**.
- ✓ Calculate the monthly **% Free/Reduced Price participation** for the month, and indicate if the 25% F/RP eligibility requirement was met (*For Profit Centers only*).
- ✓ Track the Monthly F/RP/AS numbers on the **Participant Eligibility Roster** for the Fiscal Year.
- ✓ Enter monthly participant eligibility (F/RP/AS) with monthly claim in the Washington Integrated Nutrition System (WINS).
