## January Apportionment | A Few Notes

This is a big month for apportionment as we adjust distributions based on annual average FTE and funding based on carryover/recovery data collected from last year's financial reports. Please review your reports related to carryover/recovery, PSES compliance, K-3 compliance, and K-12 46:1000 compliance. Please make any necessary adjustments to your enrollment reporting, S-275 reporting or submit appropriate Smartsheet information to address any discrepancies you may find.

Also, please note that we were not able to make the carryover and recovery calculations for CTE as part of January apportionment, due to the changes in calculations that were made in the last legislative session. We intend to address program 31 and 34 carryover and recovery with February apportionment.
