

Career and Technical Education (CTE) Course Resubmission Schedule

Local Education Agencies (LEAs) must ensure that CTE courses and programs are approved pursuant to requirements authorized by Revised Code of Washington (RCW) [28A.700.010](#) in order to be eligible for [state CTE enhanced funding](#). As the OSPI continues to evaluate and restructure state-level systems for approving CTE programs, we have issued Verification Reports to support districts, Skills Centers, and State-Tribal Education Compact schools to evaluate course eligibility for CTE enhanced funding and to support LEAs documentation of state approval of CTE courses.

To complement OSPI's Verification Report approach (launched Fall 2023 and used as approval for existing courses beginning in 2024–25), the following process adds a structured review of potentially outdated courses. Using the Program Approval cycle's historical group assignments (industry pathway/cluster), OSPI will generate the annual Verification Report as usual and **flag (highlighted in yellow)** those courses targeted for review—based on the **below Group assignment**, age of framework, and CIP/code status.

1. **Allow** the course to expire (course will sunset by January 1, 2027), *or*
2. **Reestablish** the course by **submitting a new Course Application in EDS** if they intend to offer it in the Spring of the **2026–27 school year**, with a priority submission deadline of **October 15, 2026**, to allow thoughtful local review.

This enhancement preserves the Verification Report's efficiency while reinforcing quality and renewal consistent with OSPI's [CTE Program Standards](#) and [statutory expectations](#) for industry alignment, advisory oversight, and rigorous frameworks.
