

Statewide Accountability System

Budget Language

\$450,000 of the general fund—state appropriation for fiscal year 2024 and \$450,000 of the general fund—state appropriation for fiscal year 2025 are provided solely for the superintendent of public instruction to develop and implement a statewide accountability system to address absenteeism and to improve student graduation rates. The system must use data to engage schools and districts in identifying successful strategies and systems that are based on federal and state accountability measures. Funding may also support the effort to provide assistance about successful strategies and systems to districts and schools that are underperforming in the targeted student subgroups.

Proviso Purpose

The purpose of the proviso is to create and maintain a data system supported by the Office of Superintendent of Public Instruction (OSPI). This system helps the state meet its reporting requirements and improve schools, focusing on graduation rates and absenteeism, with a focus on equity. All funds were used for this purpose and fall under two main areas:

- 1) Implement a statewide accountability system (Washington State Report Card) and other tools to report data on absenteeism and graduation rates.
- 2) Use data and funds from this proviso to help schools and districts use successful strategies to support student success, especially for students who face the most challenges to equitable educational opportunities.

Services Provided

The following activities were carried out in FY2025 to implement a statewide accountability system:

OSPI maintains the Washington State Report Card, which shows how schools, districts, and student groups are doing based on federal and state rules. OSPI also makes special reports and dashboards using Tableau for their staff and school districts to use. These services are done through the following activities:

- 1) Continue to keep the Tableau server running smoothly, which lets districts securely access Tableau workbooks and visualizations. This helps with the statewide accountability system and the Washington State Report Card. It also provides a central place to report all OSPI's school and district performance measures. Tableau licenses and maintenance are updated every year. The equipment ordered included:
 - a. Renewal of Desktop Professional licenses for OSPI program and technical staff and one year maintenance.



- b. Purchase of two Advanced Management Server-Core
- 2) Successfully upgraded Tableau server to ensure continued operation with assistance through a vendor contract to provide specialized project management and technical consultant services to upgrade the server to meet service requirements (technical architect, project manager, senior technical architect).
- 3) Updated documentation on the process to move data from disparate databases across the agency into the Accountability Reporting Server (Tableau) server. Documentation is critical to ensuring consistent calculation of measures as well as repeatable processes over time.
- 4) Worked with experts in the agency to make sure the data and visualizations were correct and useful.
- 5) Helped with data analysis at the agency and program level to support teamwork.
- 6) Managed data governance to improve data quality and performance.
- 7) Updated the Washington State Report Card several times in 2025, adding new measures and features.
- 8) Provided schools and districts access to data visualizations and student-level data to support successful strategies for improvement. The measures include absenteeism, graduation rates, math and ELA proficiency, English learner progress, 9th grade on-track, and dual credit participation. The measures are broken down by race/ethnicity, income, disability, foster care, military family, and English learner status. This ensures visibility of student group performance.

Criteria for Receiving Services/Grants

All schools and districts have access to Report Card and district-facing accountability data.

OSPI continues to look for the most efficient ways to provide comprehensive and versatile data for schools and districts as well as public-facing data.

Major Challenges Faced by Program(s)

Maintaining Tableau is costly, and OSPI has had some concerns about the level of support purchased from Tableau when there are issues. We put mitigations in place to ensure the server is updated and can be recovered in the event of an emergency.

OSPI is committed to continuously evaluating and enhancing our technology landscape to provide the best, most cost-effective solutions for data reporting. We recognize that the Report Card is a vital tool in meeting legislative reporting requirements and presenting comprehensive information about Washington's education system.
