AGREED ORDER OF PERMANENT REVOCATION

COMES NOW the Office of Superintendent of Public Instruction, under the authority granted by the laws of the state of Washington, having reviewed the file of the above-referenced case, and having considered the entire evidence contained therein, does hereby stipulate by and between the Office of Professional Practices (OPP), Office of Superintendent of Public Instruction (OSPI), and James Mobley, that the Washington Education Certificate, No. 323510H, of James Mobley, shall be permanently revoked, based on the Findings of Fact and Conclusions of Law set forth below:

FINDINGS OF FACT

1. James Mobley was issued a Washington Education Certificate, No. 323510H, on July 26, 1993. That certificate currently remains valid.
2. James Mobley was employed by the Tenino School District.

3. On January 17, 2013, the Office of Professional Practices (OPP), within OSPI, received a complaint letter from the Superintendent of the Tenino School District alleging a lack of personal fitness, or a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) 181-87, by James Mobley.

4. On January 16, 2013, a Complaint for Violation for Receipt of Material Constituting or Containing Child Pornography, 18 U.S.C. 2252 (a)(2) and (b)(1), and Possession of Child Pornography, 18 U.S.C 2252 (a)(4)(B) and (b)(2), was filed for James Mobley; United States District Court, Western District of Washington.

5. On January 16, 2013, James Mobley was arrested and taken into custody by U.S. Postal Inspectors.

6. On January 16, 2013, James Mobley was placed on Administrative Leave by the Tenino School District.

7. On February 11, 2013, James Mobley signed a Settlement Agreement resigning his employment from the Tenino School District effective August 31, 2013.

8. On July 10, 2013, a Federal Indictment for Receipt of Child Pornography , 18 U.S.C. 2252 (a)(2) and (b)(1), and Possession of Child Pornography, 18 U.S.C 2252 (a)(4)(B) and (b)(2), was issued for James Mobley; United States District Court, Western District of Washington #CR13-5407RBL.

9. On December 27, 2013, James Mobley signed a Plea Agreement for United States District Court, Western District of Washington, Case No. CR13-5407RBL. In the plea agreement, James Mobley entered a plea of guilty to the following charge; Possession of Child Pornography, 18 U.S.C 2252 (a)(4)(B) and (b)(2).

10. Possession of Child Pornography, 18 U.S.C 2252 (a)(4)(B) and (b)(2) is comparable to Revised Code of Washington (RCW) 9.68A.070, Possession of Depiction of Minor Engaged in Sexually Explicit Conduct.

11. James Mobley has pleaded guilty or been convicted of a crime identified in Revised Code of Washington (RCW) 28A.410.090. Such a plea or conviction authorizes OSPI to permanently revoke the Education Certificate.

12. Good moral character and personal fitness is a continuing requirement to maintain a Washington Education Certificate.

CONCLUSIONS OF LAW

1. OSPI has jurisdiction over James Mobley and over the subject matter of this action.
2. OSPI has shown by clear and convincing evidence that the Washington Education Certificate No. 323510H, of James Mobley, should be revoked, for unprofessional conduct and/or lack of good moral character or personal fitness. RCW 28A.410.090; WAC 181-86-075; WAC 181-86-013; WAC 181-86-014.

ORDER

Therefore, it is hereby ordered and agreed that that the Washington Education Certificate, No. 323510H, of James Mobley be permanently revoked.
