Your Task

 Who was involved in the conflict.
 What the conflict was.
 When the conflict took place.
 Where the conflict took place.
- Provide background on the causes of the conflict by explaining two or more factors that helped cause the conflict.
- □ Provide reasons for your claim, including one of the following:
 - An analysis of how the conflict might not have occurred had one or more of the main causal factors been absent.
 - An evaluation of why at least one factor is more important than the others.
- □ Refer explicitly in the paper or presentation to three or more credible sources that provide relevant information:
 - Cite your sources when you draw information from them: for instance, when you summarize, paraphrase, or quote, and when you refer to facts, figures, and ideas.
 - Provide complete publication information for each source in your bibliography or list of works cited.
